Festival Follow-up as UN75 comes to an end

Marking the end of the UN75 anniversaries, we have given the UN Secretary-General the Action Plan, <u>Urgent Actions for a More Secure World</u>, that many of you helped to create at our UN75 Festival in October. We had planned physically to hand this to him in London on Sunday (10th January 2021) to mark the 75th anniversary of the first meetings of the UN General Assembly and the UN Security Council, which had been in London.

Due to the pandemic, his visit has had to be cancelled, but, thanks to the wonders of digital technology, we have been able to get the plan to him in New York.

Do go to the pages on the Festival website showing the actions for <u>individuals</u>, <u>communities</u>, <u>nations</u> and <u>the UN</u>, and share ideas and challenges on these actions for building a more secure world. We shall, of course, continue to follow up the Actions and are delighted that UNA Westminster are acting on the need for pandemic preparedness with a webinar in April (date not yet fixed). Please <u>get in touch</u> if you have special interest in this subject and would like to help with this action.

We are also preparing some assemblies for schools based on material from the Festival; please <u>contact me</u> if you would like to engage with this. We would welcome support in creating the assemblies, as well as links with schools who would like to try out one or two and help us improve them.

I'm sure any of you who missed it (and even some who saw it live) will <u>value seeing</u> the service broadcast from Methodist Central Hall on the morning of 10th January. Much of the service commemorates the first meeting of the UN General Assembly in that hall 75 years ago, with contributions from Sir Peter Marshall, Dame Barbara Woodward, the UK contingent of the UN Peacekeeping troops in Mali, Secretary-General António Guterres, Fabrizio Hochschild-Drummond, as well as our own David Wardrop. The service also includes the announcement that, thanks mainly to the vision and perseverance of UNA Westminster, led by David Wardrop, the area outside Methodist Central Hall and the QE II Conference Centre is being renamed United Nations Green.

2021 – Our New Year Solution: Mitigating Climate Change – Are We Doing Enough? There are TWO vital actions we must take:

1. CHANGE OUR CONSUMPTION PATTERNS: REDUCING OUR CARBON FOOTPRINT by AVOIDING, RECYCLING AND REDUCING our consumption of resources which create carbon emissions. We must urgently aim to become NET CARBON NEUTRAL as soon as possible.

UNA Canterbury Branch News December 2020

One more of our planned aspirations was achieved in 2020, despite the covid constraints!

On United Nations Day 2020, (24th October) we were delighted that His Worship the Lord Mayor of Canterbury, Cllr. Pat Todd, took time out of his planned family reunion, to raise the UN flag in Canterbury for the first time. It flew for five days in Dane John Gardens and will now be raised annually.

As previously mentioned Dr Chandramohan led our first SDG-17 North-South partnership exploratory meeting between participants from both Canterbury and Entebbe. Bala was aided by the municipality's Community Development & SDG Officer, Mr Paul Kimuli, who had previously provided an extensive list of actions and initiatives which are being addressed within Entebbe.

Councillor Vincent De Paul Kayanja, the Worshipful Mayor of Entebbe, welcomed this exploratory opportunity. He then participated in the meeting with five other officers and four business/civil society group representatives. We found a number of issues in common which may form the basis for mutual exploration and support within smaller themed groups. Likely areas of further activity are: the interface and co-operation between business, municipality and civil society, based on the UK's Business Improvement District (BID) concept; climate change impacts and environmentally sensitive tourism; support for young people's development; a school-to-school link. Subsequently we have joined with Entebbe in a bid for a British Council COP26 based grant.

Further to our September meeting, exploring the need for the Treaty on the Prohibition of Nuclear Weapons (TPNW), we were delighted that the Treaty had gained its 50th ratification, meaning that this ground-breaking Treaty comprehensively prohibiting nuclear weapons and related activity will become legally binding in international law on 22 January 2021. Many members are looking forward to attending the Model Citizens' Assembly to discuss "Should the UK Join the UN's Treaty to Prohibit Nuclear Weapons (TPNW)?" on the 10th January.

We held a virtual Annual General Meeting on the 5th December 2020 with nine members present. In the absence

of any volunteers to take on executive roles, all of the officers will continue in post for the present. However, it is unfortunate that our Chair, Treasurer/ Environmental Officer have now moved to France and will only be available for the Planning meeting on the 23rd January.

We are exploring whether we can find members willing to take on these key roles for Canterbury. Alternatively we are exploring whether some form of association might be formed with UNA Deal branch, who are equally limited in the number of people willing to help organise the branch, thus forming an East Kent alliance or stand-alone branch.

Despite a hitch with the technology, five guests joined us for an insightful exploration of the Convention on the Prevention and Punishment of the Crime of Genocide by Linda Melvern, a distinguised journalist. She juxtaposed these 1948 principles with the realities and difficulties experienced in effecting safe UN intervention within the current system. Her presentation was based especially on her concerns for the Rwanda genocide of 1974 which, like many other areas, has still not been adequately resolved within these and surrounding countries.
