From Our Chair

At the recent annual memorial service marking the deaths of UN civilian, military and police personnel who have died in the line of duty, UN Secretary-General António Guterres said "To our staff still serving in crisis zones across the globe, I say: We will not accept the killing of UN personnel".

The Secretary-General <u>paid tribute</u> to the 168 UN men and women who died in the line of duty in 2024, noting at the annual memorial that their deaths are a "reminder of the thousands of UN personnel who serve around the world today, carrying out the missions entrusted to them by the countries that make up these United Nations." 2024 was "especially devastating" in Gaza, where 126 UN staff members were killed, all but one of whom served with UNRWA. More than 170 journalists have also been killed since 7th October 2023 while reporting on the war in Gaza. We must make our voices heard to help end this devastation and suffering with a solution fully respecting the human rights of Palestinians as well as Israelis.

Campaigning

As flagged in the last Pulse, we were pleased to get <u>detailed response from the Foreign Office (FCDO)</u> to this year's updates in our <u>members and supporters resolutions</u>. This provides an opportunity for members and supporters to start or build on a relationship with your local MP: pressing for more action where you feel the response is insufficient; and indicating your support for positive moves. You can also ask them to bring further questions to the attention of the relevant minister, in which case the minister is expected to respond. <u>Our Policy Committee</u> would be very interested to see copies of any correspondence you get back from your MP and to hear any suggestion you have for other ways we can support you in undertaking this important work.

We encourage members to engage with their MPs when trying to influence UK government policy. We can, of course, all also write directly to the relevant ministers, but ministers usually read only letters from MPs (while most other letters are dealt with by officials), so we prioritise getting MPs on board and encouraging them to contact the relevant ministers and ask questions in the House. It is important to give your address when you write, so your MP knows you are a constituent.

Israel/Palestine



In light of the continuing horrific suffering in Gaza, our government needs our support, encouragement and pressure to follow up the 19th May statement of the Prime Minister. We have updated our draft letter for MPs to include reference to the disastrous Gaza Humanitarian Foundation's activities. Here is a summary you could adapt (but keep to fewer than 1000 charcters) and submit to Contact Number 10. We are urging urge the government to:

- put maximum pressure for the reintroduction of full, impartial and independent humanitarian support
- end all arms supplies to Israel
- apply full sanctions to Israel
- support regional diplomacy to build a long-term peace
- and acting with partners including France and Canada – recognise the state of Palestine now, at this time of great peril.

Low- and Middle-Income Country Debt



Debt and austerity drive authoritarianism across the Global South, according to a new report. The United Nation's Financing for Development conference (FfD4) in Seville at the end of June could be a pivotal moment for debt justice. A generation ago, campaigners around the world won \$130bn in debt cancellation for countries in debt crisis, which had a real impact on people's lives – with more money available to fund public services like education and healthcare. But the underlying issues that caused the crisis were never addressed. Decades on, there is still no fast, effective and fair debt relief process for countries in crisis. Sign this petition to call for a binding, transparent and inclusive legal framework, a UN Framework Convention on Sovereign Debt.

If you are following this up with your MP, our resolution on the <u>UK Aid budget</u> also proposed that the UK should help developing countries improve their own finances and development by improving their trading

conditions; investing in programmes to increase diaspora contributions from citizens living and working abroad and supporting Tax for Development initiatives including taxing transnational companies and wealthier citizens more effectively.

Joint Action for Climate and Nature



On **9 July**, there will be a mass lobby of parliament to help shape a better future, coordinated by the Climate Coalition of which LASER is a member.

Participants will ask their MPs to:

- deliver vital funding to communities hit hardest by climate change here and around the world
- cut bills, back UK jobs and secure a greener fairer future for all
- restore nature to create a safer, healthier future.

Marking UN80



UN80 gives many opportunities to engage your local community, media and leaders in thinking about the work of the UN and our roles in helping its effectiveness. There are three key dates that you could use: 26 June (when the Charter was signed in San Francisco); UN Day (24 October, when the UN Charter came into effect); 10 January 2026 (80 years since the first meeting of the UN General Assembly, which was held in London).

Some groups mark the day by their local Council flying the UN flag, floodlighting its building in blue, or inviting MP(s) and other local leaders and media to a flag-raising ceremony. Note that an Eightieth Anniversary is an Oak Anniversary, so you might like to mark UN80 by planting an oak in a prominent local position, with appropriate ceremony, community and media involvement, and plaque.

UNA Northern Ireland have kindly agreed to share this letter they successfully wrote to all their local Councils in case it might be useful to other groups.

Several LASER UNA groups, working with their local Councils on <u>local implementation</u> of the <u>Sustainable Development Goals (SDGs</u>), have created this Working Group to support and learn from each other. Some UNA Groups have several years' experience of this work and have established effective local SDG committees; others are just starting. Groups usually work with other local civil society groups: to consider how best Councils can develop their infrastructure to meet local needs; to persuade their Councils to adopt the SDGs into their strategic planning; and to encourage their Councils to submit their Voluntary National

Reviews to the United Nations.

SDG Guidance and Use Cases

Since September 2024, this Working Group has been meeting every eight weeks to exchange experience and collaborate to promote the adoption and implementation of the SDGs by UNA groups. One of the group's members is a UK representative at the ISO/UNDP PAS 53002:2024, *Guidelines for contributing to the United Nations Sustainable Development Goals (SDGs)*. The ISO/UNDP guidelines address: setting SDG impact objectives and targets; engaging with stakeholders; collecting data on impacts; generating options; making risk-based decisions; and understanding trade-offs to increase positive impact. We intend to generate an overview resource from this standard for the benefit of other UNA groups. We also discuss specific SDG adoption, research and use cases by various groups including SDG initiatives on SDG2 (hunger) and SDG 13 (climate impact) in UNA Enfield and the Barnets.

Imagining a UN Fit for the 21st Century

The classical and inflexible governance of the UN, built around classical institutional models of post war era, renders it unfit for a dynamic and new multipolar world order. The UN governance can and should be re-engineered for the brave new world.

This Working Group is adopting a novel research method creatively to explore the drivers and opportunities for a reformed structure and governance, leading to a UN that will be agile, inclusive, representative, transparent, accountable and fair to the needs, rights and values of the international community in this century of exponential change and shifting power dynamics. It is intended to produce a consensus-based, ideal structure/governance/regulatory model and associated brief narrative for the UN in the 21st century.

Systemic Transformation Network



This Working Group was launched at the UNA Groups' Meeting on 27 May by **Professor Barrie Oxtoby** of UNA Shropshire. Barrie Oxtoby has many years of experience working with the UN, including with **Kofi Annan**, on the <u>UN Sustainable Development</u> Goals (SDGs). Barrie and Suheil Shahryar (UNA Harpenden) are planning to develop systemic transformation frameworks to deliver the SDGs.

UN Security Council Veto Reform

This Working Group was convened by UNA Luton in November 2024 and brought together a few members, with some international experts as advisers, to consider how to make the UN Security Council more effective, with particular emphasis on the veto. The work was initiated because of policy commitments made by UNA Luton and UNA Bexhill and Hastings.

The group has proposed a solution it calls the *Accountable Veto Resolution Initiative (AVRI)*. A resolution of the UN General Assembly would ask the Elected Members of the Security Council to test every veto for compliance with the UN Charter and, if necessary, call an emergency session of the Assembly with a recommendation for collective action. This needs only a General Assembly resolution passed by a simple majority and does not require amendment of the UN Charter.

The group had its resolution accepted at the LASER Policy Conference on 15 March and the full AVRI proposal was launched at the UNA-UK conference on 12 April. The conference asked the UNA-UK Board to consider adopting it as national policy. UNA Scotland arranged an online webinar on 22 May to discuss this initiative. The discussion following the presentation was very productive and led to a further broad-based meeting on 30 May called by Peace Child International. The outcome of that meeting was that the Impact Coalition on Just Institutions and the ICJ (International Court of Justice) offered to coordinate further meetings to progress both the AVRI and Professor Jennifer Trahan's ICJ Resolution which AVRI endorses and to which is closely linked. The working group has now ceased its deliberations because the task from here on is to work with others to get the AVRI resolution laid before the General Assembly as soon as possible.
